1) Call to Order

B. CSEC updates:

Schema/Recorder Replacement:

Juan Ramos- We have our new match rate. 3 Counties are at 98% now. We are about half way there now. We are finishing up our fiscal year. We will start our new projects once that is completed which will include recorder replacements. This legislative session we did not receive any equipment money. This will require notification to CSEC to move money.

Text to 9-1-1:

Juan Ramos- Text to 9-1-1 POs have been issued. The vendor West Safety Solutions is waiting for a project manager to be assigned.

Workstation Equipment Refresh: We did not get equipment money so this will have to be pushed back a little. We want to get the net clocks and recorders in. Those are priority for the Text to 9-1-1 unless CSEC comes out and says that we can have equipment money. Mapflex updates will have to wait awhile.

Juan is meeting with Airbus soon. We are re-evaluating the network for economical options. The redundant path problem with Hill Country Telephone is still an issue. We do have options to transfer those calls. Juan will talk with Airbus about it.

PSAP & Database ILA's:

All of these have been signed. Most were done by Docusign.

We have a TARC meeting tomorrow. We will discuss GIS and will have changes to our compliance. We will find out what that requires on the PSAP level if any.

They opened up an application process for assistance to anyone affected by Hurricane Harvey from Texas APCO. We will send that out.

TCOLE conference is in Oct in Corpus Christi from Oct 16-19.

Paul Quintero- FIRE/EMS is missing 3 fields that we need to add. We will also need to populate other fields that will become mandatory. Zipcodes, Place (business, residence), and landmarks (county offices, churches, schools, etc.).

We do have Pub Ed items for everyone to take today. We will be delivering to some counties.

C. WSC Updates:

Barry Bradford- Airbus pushed all updates to the systems. Everything is running well. There are no tickets out right now.

5) County Reports:

A. Atascosa County:

Linda Foster- Wanted to know where they are at with the Lytle issue which was getting the dispatch back to Medina County. Paul is working with Lydia at CPS on this. Carey Reed suggested deleting any that are not in her county.

B. Bandera County:

Carey Reed- We had a cut Sep 1st and 9-1-1 was down for the most part.

New version of Mapflex was already addressed.

We got our net clock antennaes back up.

Do you have the contingency plan that shows who is backing up and routing, etc which was discussed at last meeting? Juan did send this in June out but will check and email it out again to everyone.

Juan sent an email out on 7-31-17 that an Intrado Mapflex update was done. We were not informed ahead of time that an update was done. Can you please let us know a week ahead so we can send you all the updated info for the update? You can put the appraisal district items in the outside database though.

Medina County wireless-They are still coming in as Phase 0 on ours and they are getting them as Phase 2 in Medina County. We haven't done the mobile switching.

Raynell Wilkes- The contingency plan we received by email just shows a backup plan. We need to know the phone numbers and not just a diagram. We need to know where all these route to. Can we please get this? The old one had all the counties, phone #s, circuit IDs, etc. We believe this was actually a network diagram that came from Intrado. Juan will check and see what we have and will send it out.

Les Metzler- Wants to know what the timeline is to replace the recorders and net clocks. Gillespie is looking into changing theirs. Juan says that normally we can get invoiced for AACOG's portion and Gillespie will get invoiced for theirs.
